RE INCREASE of the Cathay Pacific Fuel Surcharge

Dear agent,

Please be advised that the Cathay Pacific fuel surcharge will be revised for **all tickets issued or reissued (due to rerouting and or rebooking on 1st coupon) on/after 18 March 2026.**

The following will apply:

- 1) The fuel surcharge will be effective for **all tickets issued or reissued (due to rerouting and or rebooking on 1st coupon) on/after 18 March 2026 and travel on/after 18 March 2026.**
- 2) **Increased from US\$ 72.90 to US\$ 149.20** (local equivalent) for Cathay Pacific flight coupons between Hong Kong and South West Pacific, North America, Europe, Middle East, Africa.
between Japan and USA,
between USA/Spain and Brazil/Chile/Peru,
between Australia/New Zealand and Chile,
between United Kingdom/South Africa and Brazil
between Qatar and Brazil/Croatia/Kenya/Russia/Serbia/Seychelles/South Africa/Ukraine
- 3) **Increased from US\$ 33.80 to US\$ 69.40** (local equivalent) for Cathay Pacific flight coupons between Hong Kong and South Asia Sub-Continent (Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka).
- 4) **Increased from US\$ 18.20 to US\$ 37.20** (local equivalent) for Cathay Pacific flight coupons not mentioned under point 2 and 3.
- 5) The fuel surcharges apply **per passenger per** Cathay Pacific flight coupon and will be collected from **all** passengers regardless of ticket stock.
- 6) This applies to **all** fare types and is regardless of class of travel including Frequent Flyer Program.
- 7) There is no exemption for any category passenger (such as children/infants/AD).
- 8) The fuel surcharge is to be collected at point of sale or ticket issue/reissue and must show as **//YR//** in the tax/fees/charges box of the ticket.
- 9) If interline is involved and the interline carrier applies a fuel surcharge, this charge must be paid. When Cathay Pacific acts as an interline carrier for another airline, the CX fuel surcharge must be applied as well.

10) All CRS systems will be updated accordingly.

11) The surcharges will apply until further notice.
